Preparing to Bargain

We are a little more than a month into the school year. While there certainly have been some challenges, it feels very much like a more typical start of the year. We have seen issues related to Special Education, changing enrollment patterns, and classified staffing shortages. MEA is working with MSD to address these concerns. MEA will continue to monitor the staffing shortages and will work with the district to address shortages over the coming weeks. Remember, the previous staffing MOAs expired at the end of last school year, and we are now following the main CBA for covering classes. For information on covering classes, please refer to CBA Article 8.3 'covering classes' on page 53.

As you recall, last year we ratified a one-year contract extension. This contract extension launched several committees that are currently working, or preparing to work, to address various issues related to the upcoming bargain, including school counseling, special education, equity, and the culture and climate survey. This year we will negotiate a full contract agreement, expect information from MEA in the next month or so on how we will be soliciting input from all MEA members and the timeline for the bargaining process.

Student Loan Information – Deadline Approaching

<u>Please CLICK HERE for an updated fact sheet</u> from NEA about both the Biden Administration Student Debt Relief plan, and the Public Service Loan Forgiveness (PSLF) waiver.

The following was sent by Pilchuck directly to your home emails on 10-12:

Public Service Loan Forgiveness Waiver is Ending!

Public Service Loan Forgiveness (PSLF) is *different* from the one-time loan relief up to \$20,000 recently announced by the Biden Administration. PSFL is a program for people who work in public service in federal, state, tribal, or local government, or for a non-profit organization.

The temporary Public Service Loan Forgiveness (PSLF) waiver, which has delivered \$10 billion in loan forgiveness for public-service workers over the past nine months, is set to *expire on October 31, 2022*. This waiver expanded which loans and payments are eligible for forgiveness. Prior to this waiver, 90% of applications were denied! If you have student loan debt, this is the time to look into applying for PSLF. <u>PSLF Explainer in 30 seconds - YouTube</u>

How can you learn more:

As an NEA member, you have several options.

- Go to <u>NEA Student Debt Navigator powered by Savi | NEA Member Benefits</u> (neamb.com). This tool (Savi) is free to NEA members for one year.
